Vann stated that the meeting had been called at the request of three or more voting members to discuss changes in out-of-state cookoff rules. Vann declared the proxy from CONCHO VALLEY POD-CASI invalid because it did not designate a specific individual to act in behalf of the CONCHO VALLEY POD.

Ken Hudspeth, Chairman of the Out-of-State Rules Committee, recognized Ken Novy, Bob Whitefield, Stuart Frye and Jim Sabo as the other members of the committee. Ken Hudspeth (COWTOWN-POD) made a motion that the rules promulgated by the committee (attached hereto) be adopted as presented. Bert Reinke (PURGATORY CREEK POD) seconded. Frank Murphy (SPACE CITY POD)

made a motion to amend the proposed changes. His proposed amendment was that any cookoff where the top three cooks are automatically qualified to cook at Terlingua would require a minimum of 50 cooks. There was no second to the amendment.

Richard Knight (Board of Directors) made a motion that Section I. #3 be amended to add: "based on the prior Terlingua year." Ken Hudspeth (COWTOWN) seconded the amendment. The vote on the amendment carried. The vote on the out-of-state rules, as amended was taken and carried unanimously.

Robert Bell (GOLDEN TRIANGLE POD) made a motion that the meeting adjourn. Rex Jones (Board of Directors) seconded. Motion carried.
