President Kris Hudspeth called the meeting to order at 9:00 a.m.

Kris Hudspeth said, "America was established with thirteen original colonies. There are 13 stripes on our flags. A few weeks ago, we lost 13 service personnel in Afghanistan. Today marks the 20th anniversary of the 9-11 terrorist attack on New York with the American Flight 11 and United Flight 175, the Pentagon with American Flight 77 and United Flight 93 which was crashed in St Holford, Pennsylvania. At this time, I would like to ask everyone that is a United States active duty or Veteran to please stand. (claps) There are only two defining forces that have offered to die for us. Our Lord Jesus Christ Savior died for our soul and the American soldier died for our freedom. I ask that you observe a moment of silence this morning in memory of those we lost in Kabul and the memory of those affected by the tragedy of 9-11-2001.

Patti Myers Jones led with an invocation.

Kris Hudspeth led the organization in the Pledge of Allegiance.

Keith Karaff called Cecelia Rivera and Brandi Rather to the front to give the credential report

This year the Credentials Committee completed the review of Pod Annual reports. Here are the findings and recommendations:

The CASI Executive Director has been notified that the following Pods have dissolved:

Piney Woods Pod High Desert Pod Alamo Area Pod Pod on the Pedernales

The credentials committee has found that one Pod is in violation of Article XIII, Section 2.e which states:

e. Submit evidence of Section 2(a)-(d) to the CASI Executive Director as part of the Great Peppers'

Meeting credential process. This evidence must be sent in time to meet the stated deadline.

The Credentials Committee recommends that Yavapai Chili Society be placed on probation and not seated at the 2021 Great Peppers' Meeting.

The Credentials Committee found that five Pods did schedule their Pod cookoffs but due to COVID related issues were not able to hold them. By acting in good faith and striving to fulfill their commitment per the CASI Bylaws, it is the recommendation of the Credentials Committee that the following Pods be seated at the 2021 Great Peppers' Meeting:

2021 Credentials Committee

Nancy Hewlett, Secretary, called the roll and informed that a quorum was present.

Keith Karaff said the minutes and the financials were in a separate envelope from last year.

A motion was made by Ron Barnes of Cowtown to accept the minutes of the 2020 GPM Meeting, seconded by Patti Myers Jones of Rose City Pod. Motion passed.

Kris Hudspeth gave the following message: Eight years seems like a long time, but the truth is, it goes by in the blink of an eye. The weekend of the Great Peppers Meeting marked the end of a journey that started eight years ago in Arlington. Elected as one of, if not the, youngest CASI Directors, to less than 6 months later being elected as the youngest Vice President, to being the youngest CASI President at the age of 32. There have been too many people that said, "you're too young, you're too new, you don't have enough experience, you're too influenced by family, you're too influenced by friends, etc.". From the bottom of my heart, thank you. I am not being sarcastic either. You gave me motivation each and every time things got tough. I thrive on chaos and hate; it is what drives me to step up and lead. Those phrases, that venom, it drove me to be great every single day, and in turn push those with me on the Board to the same standards. Eight years ago, enough Great Peppers saw that spark in me to elect me to the Board and bring that fire every day. There has been a lot of things happen in the eight years that I have been on the Board: We were broke, like broke, broke, a negative operating budget, negative TICC, and less than \$50,000 in our Life reserve fund, we lost our 501(c)3, we lost our insurance coverage, we lost a major sponsor, and then we dealt with a virus that shut down the entire world. That is a lot of negatives that impacted our organization. Within two years, an operations budget was set, the TICC budget was set, and our Life Reserve fund was restored to \$100,000. We also regained our 501(c)3 status, found insurance coverage, replaced the lost major sponsor, increased our Friends of CASI program to new heights, implemented new financial controls, saw the creation of the CASI branded chili mix, added additional sponsors, increased the Life Reserve fund, and weathered the pandemic all while maintaining financial stability!! Not every decision has been popular, or well supported by some of you. As a Director, our mentality should never be, what is going to be the popular decision that is going to get me brownie points. That is what caused all of the negative financial issues. We allowed the entitlement attitude to influence spending, and we were running out of money. The mentality that was fostered

over these last eight years was to make the decision that was best for CASI as a whole. If you are doing right by CASI, the membership will understand...they may not like it, but they will understand. Over the last 18 months, there have been many of those decisions that have been made. Moratoriums, point changes, rolling over points, not reducing points, no printed Trails, moving the GPM, etc. In fact, I have no doubt that some of these things will be beat on a little more. I can see both sides to a lot of these things, but tough decisions had to be made. Personally, I didn't like having to make some of these decisions, but it was the right thing to do for CASI. This is where I turn it back on y'all. Don't like what the Board is doing, or you don't agree with how a director is performing. DO SOMETHING ABOUT IT! Recruit new candidates to run for the Board, hold them accountable, ASK A TOUGH QUESTION AT THE ROUNDTABLE, COMMUNICATE WITH THE BOARD, don't wait until you have an audience at the GPM to build your ego to address the board, show up at the damn meeting and be on the agenda. As Marshall Mathers once said, "Nowadays everybody wanna talk like they got something to say, but nothing comes out when they move their lips, it's just a bunch of gibberish" It's like everyone forgot how to grow an organization or raise money. You want CASI to bring back the Trails? Hold more than your one required cookoff to be seated as a pod, join Friends of CASI, help recruit new members, help recruit new corporate members, HOLD A COOKING FOR CASI COOKOFF. DO SOMETHING other than complain. I realize there are some that are doing absolutely everything they can to help grow this organization. Those are the ones that should be praised. They are the ones that you should seek out to learn from. These other pods that are only hosting their one pod cookoff but causing a ruckus because the organization is evolving and changing and having to cut things out aren't doing anything to help raise more money, qualify more people for TICC, or growing membership. While we are talking about growing membership, I saw a meme the other day that said "The quickest way to kill a hobby is the veterans to be total jerks to the newbies. If you want things to flourish you have to invite and encourage new folks getting into it". I immediately sent this to Keith and said this rings so true for CASI. I cannot tell you how many new cooks I have seen come into CASI excited and willing to jump in with both feet, only to turn around and quit in less than three years because of the negativity and jerks. I know that there are a number of people that would be willing to turn their POD over to a new Great Pepper, because you have been GP for multi years, or even multiple times for multiple years, and there are some pods that are no longer with us because they can't find that next person to step up. If you are not out recruiting, being welcoming, or even beating down pod meetings by being negative to the Board, you are pushing people away! Set up a CASI Information booth at your cook-offs and explain what we do and why we do it, welcome the new cooks, help them with their recipes, BE EXCITED WHEN THEY SHOW UP, BE EVEN MORE EXCITED WHEN THEY PLACE OR BEAT YOU! If you and your pod are already doing these things.... THANK YOU! You are helping GROW CASI. If you are doing the bare minimum, GET OFF YOUR ASS AND HELP GROW THE ORGANIZATION THAT YOU "SAY" YOU LOVE. It's not that hard people!! Take your role as a leader of a local chapter seriously. The membership numbers are not falling because of Board decisions or who the President of the Organization is, the membership numbers are falling because the Great Peppers have been apathetic and unwilling to adjust. Just like every other business or event, we have to compete for people's time, attention, and money. I love the VFW, American Legion, and Elks Lodges that we support. I believe in their missions just as much as I believe in the CASI mission but be honest with yourselves. Are you getting a ton of public to these events? Are they fun and enticing people? In 90% of the events that I have been to, the answer to both of these is NO. Look for places that are already holding a crowd, where people want to hang out on the weekend, and try hosting cook-offs there! Just because you aren't at the Legion, VFW, or Elks doesn't mean that they can't still be your

charity of choice!! Find local festivals and create a relationship with them, the festival draws the crowd, we feed them lunch through the judging process, AND we get to teach them about CASI.... what a novel concept. Before I close my speech with my laundry list of thank you's, I leave you with a few final thoughts. This organization is going to grow or fail based on your collective efforts. Hold each other accountable, make chili fun again, nobody wants to go watch 15+ people stand in a parking lot and stir a pot of chili. They want to be entertained. If you can't entertain them, partner with the entertainment! Be the change that you want to see in the organization. Devote your time and talents to help it thrive! The other is to go out every day and BE GREAT. This is something that I tell my girls every day: BE GREAT today and every day. As I have explained to them "Don't take this at face value, this is deeper than just striving for greatness. Every single day is your opportunity to be a leader, a motivator, an innovator, role model, or torch bearer." I challenge each of you to BE GREAT and an ambassador for CASI. Every person you meet while wearing the logo, or at a cookoff could be the next cook, TICC Champion, Director, or Sponsor of our organization. Now to the "thank you's": To the Knight family – You have been a constant positive force in my life from beginning and it continues to this day. That coupled with the dedication and leadership that you have given CASI over the years has been invaluable, both for me and the organization. Yes, we have had disagreements and butted heads a few times over the last 8 years, but you have been there for help, guidance, and as a sounding board for the last 8 years. You have never turned down a request for help and have never pushed your opinion or ideas on to me or others on the board. Thank you for being available, honest, and loving. The fear of failing CASI was always at the forefront of my mind, fear of failing CASI pioneers like y'all was number TWO! To Tim and Connie Collier Connie you are an absolute Saint, and not just because you are married to Tim. You have supported, helped, motivated, and stood steadfast behind the decisions that CASI has made. You have been a source of council and inspiration. Tim, being able to learn from you as a new CASI Director helped tremendously. You taught each of those who served with you that it was ok to lose a fight and still be friends, and that you have to make the best decision for CASI, public opinion be damned. The constant pressure that you applied to every financial aspect of CASI was welcomed and helped make sure that we stayed on track. Thank you both for your friendship and mentorship. To Pat Krenek – You are another to fall in the category of a person that has never said no when I asked for help. Be it with handling Finals Table decorations, to assisting with shirts, embroidery, Old 320 historical information, running roundtables, etc., you have been willing to lend a hand. You are a great asset to CASI and have been a tremendous asset for Keith and me to lean on! To Candy and Jerry Ford – I found the coolest brother and sister-in-law I could have that was not directly related to me when I met you two. You were there for me in the infancy of being a CASI Director as friends and helped me through one of the toughest periods of my personal life. I can't ever thank you both enough for the support, laughter, friendship, and love that you have given me. To Past Directors – by my count, I have served with around 30 different directors over the last eight years! While that is a lot of people, there also has been a lot of consistency on the Board. Each and every Board has had unique challenges of the time, but one thing is certain, CASI does not continue to move forward without volunteers willing to step forward and take on increased roles in the organization. To those that have helped carry the CASI torch to this point, thank you...thank you for making CASI better. To those that will join the board, both today and in the future: CASI needs you. Your ideas, time, talent, and leadership will be needed as the years move forward. I hope that you will get as much out of serving CASI as I have. Well, wishes for the Board – To the new, incoming board: continue to push the organization forward. Make your decisions for what is best for CASI as a whole, solicit feedback from the entire organization, and continue to improve. Communicate with the

membership directly and continue to GROW CASI outside the state of Texas. I will always be available to help anyone of you at any point! I have saved the toughest three thank you's for the end: To Keith Karaff - To say that we have become like minded and similar would be the world's largest understatement. The mental connection that you and I have formed has been downright scary at times, but has been one of the biggest benefits to our relationship as President and ED. I have served on this Board with three Executive Directors, and all three were exactly what was needed during their terms. You have done a magnificent job over five years of leading, creating, communicating, and relaxing the Organization. Your preparation, attention to detail, and creative flair have been very valuable, and you know exactly when each of them is needed. When you joined the Board five years ago, we were friends, and I was hoping that our personalities would mesh well enough for us to be effective. After five years, we are no longer friends, but brothers (Michael and Shelley might have another name). You pushed me when I needed it, played devil's advocate, and allowed me to twist and tweak your "I've been thinking" moments in their infancy to give you the ability to create them from an idea and turn them into greatness. I could not have asked for a better partner or right hand over the last five years, and I am extremely thankful that you stuck around for this last year. I know that at moments you wanted to throw in the towel and felt like it was a horrible decision, but your influence and guidance were needed. Keith, I was better because of you, and CASI was definitely better because of you. Thank you, Michael, for sharing him with all of us for the last 5 years. To the Tribe – I started this journey 8 years ago with mom as my support system. Ask any of those who have sat up here, you have to have a support system to survive this gauntlet. As the years have gone on, our Tribe has grown by leaps and bounds. Without MY PEOPLE, eight years would not have happened. You have stuck with me, supported me, defended me, and dealt with all forms of frustration, elation, and the mental breakdowns. Thank you is not strong enough. I love each and every one of you from the bottom of my heart. To Shelley and my kids - The last eight, four, and two and half years have provided different experiences for each of you. My initial motivation to running for the Board was to help ensure that CASI would be around for you to grow up in and have the experiences that I had as a chili kid. As I have always told my girls, it is important for you to have a hobby and an outlet. It will keep you active, provide relief from your stresses, and give you a community. Find something that makes you happy and helps you serve those that are in need. Just because this chapter is over in our lives, does not mean that it will go away. CASI is family, and you will always have the connection to many of these people. Most have seen you grow up, much like they saw me grow up. Geez, some of y'all are getting OLD.;-) I love each of you more than you will ever know, but more than I love you, I can say that I am proud of each of you and who you are. You make my life complete!! To end, I say thank you again to the CASI membership. There aren't many groups that do what you do, EVERY weekend of the year. This organization is truly special, across the world. If you have not taken the time to get outside of your area to cook, or outside of your state, I encourage you to do so. Every CASI cook is like minded and is drawn to our motto and mission, and you find some of the best hospitality in the world at CASI events. Stay motivated, keep recruiting friends and family, and continue to embrace the motto of Chili, CHARITY, and Fun!

Keith Karaff gave the following speech:

Good morning. The day is finally here. This is my last time to stand before you as the ED of CASI. So, sit back, relax and let's get this over with. First, let me talk about this last year.

It was mainly a wait and see year, but you all know that. There wasn't much happening in the first part of the year then all of a sudden, areas started to open up and cookoffs were being scheduled again. Different parts of the country began to ease restrictions and we were happy to see this. This meant that our cash flow would restart and with positive thinking we could begin to discuss the 'T' word.

Now here we are once again...it worked...it didn't work...take this...don't take this...blah, blah blah....so much rhetoric and so much misinformation and just so much crap. But we continue and make plans for our organization, our membership and our championship.

You are going to hear the status reports throughout the day so there is no need to bring those up. I have worked over the last five years to 'guild the lily' so to speak. I am not going to go through and do a comprehensive list of accomplishments over five years. They are what they are, and they were what they were.

Over my time, for some unknown reason, I have become associated with three little words...no, not I love you.... I have come to discover these three little words would have some running for the hills, that is if they were spoken by me. But these three little words are more important than you can never know. These words have in them the ability to change...the ability to move forward...the ability become creative and imaginative...I guess if I am too be associated with anything...I am proud to be associated with these and what they have come to mean.

Change...

CASI is poised for a leap into the here and now. As we all know, CASI doesn't like change. You have to fight tooth and nail to make changes in this organization. Over the years, changes have been

They have the ability to expand on what has been discussed and come up with new and interesting ways to promote this organization, but they cannot succeed without the membership taking on an active role in the growth and promotion of CASI.

Over the years, I tried to involve as many Pods and members as possible in events at the Ranch, on Committees, in discussions...whatever I could find that would involve as many different members as possible from around the country. Truth be told, this was like herding cats. The key word here is involvement. People are being pulled so many different ways now and getting commitments and involvement is a major issue but until they decide that they want to contribute in a different way or become more involved, there is nothing that can be done.

Someone has said that most of the sitting BOD don't have a clue about the history of CASI. While this statement was asinine when you look at the makeup of the BOD currently, this does hold true for some of the newer members. And that is not a bad thing.

This organization is 55 years old. The split happened over 30 years ago. There have been interesting and tumultuous times in the history of CASI, most of you in this room know this. A lot of the people in this room know, understand and experienced the difficult times that are now part of the fabric and makeup of not only CASI, but other chili groups as well. Friendships were lost, heated words, lawsuits...you name it, it got ugly. I have only been a part of CASI for just a little over 20 years now, but I was "brought up" so to speak on one-sided, biased information. CASI is an international organization. We have members all across the country. We all know this. Most of the members outside Texas don't care about old feuds and old history. They don't know about all the animosity with another cookoff, nor do they care. They care only about this organization. This is the group they have joined. This is the group that they promote to their friends. This is the group that they have bonded with and created lasting relationships. It is now time put all of this out of the present and future narratives.

Only you and the membership can change the public face of this organization. It is up to every single member to promote CASI. The membership must take an active role in recruiting new cooks. You cannot put all of this on the shoulders of the Board of Directors. These people that have volunteered their time, talent, efforts, imagination, creativity and let's not forget; they have accepted a financial burden for multiple years. They do this because they believe in what we do. They have a passion for CASI, just like you seated out here. These people are not here for you continuously berate, bash, criticize day in and day out. They are here to do a job. Because if you keep this up, you find yourself in the same position

you find yourself in now. No ONE WANTS TO RUN FOR THE BOARD. You have done that with your constant negativity and undeserved criticism. Why in the world would someone want to put themselves in a position to be ridiculed by those very individuals that won't get off their ass to do anything? Negative outside influences that think they know best and in reality, they don't have a clue. Individuals that believe they know exactly how things should work and have not lifted a finger to know more about the organization or volunteered. If you all are so knowledgeable and experienced, then run for the Board or keep your mouth shut. Soapbox over......

When I started five years ago I did so to give back to an organization and people that have given so much to me. People that have become family. People that were there when I needed them. 2020 will go into the books as the year that really sucked. Sleepless nights. Stressed so tight you can bounce a quarter off your back. Indecisions about decisions. Dealing with a situation that no one has had to deal with before. There was no past to turn to. There was nothing written to help you out. You guide with what you think is best when it is all on your shoulders. You hope the decisions are right. You hope that when all is said and done, that there is still a strong, financially stable organization to come back to; and there was. Then, when you get to the end of those 6-8 months, the tongues start wagging, you get here about how awful decisions were made. How they were wrong and that they are detrimental to one area or another. I am extremely proud of the members of the Board of 2019-2020 and 2020-2021. We worked together to overcome enormous obstacles successfully. We succeeded because of you.

When I first started cooking, I had the opportunity to meet a person that at the time that would inadvertently shape my views and thoughts about CASI. Very open, friendly and you could see the passion, determination and push they had for this organization. Time passed and we became great friends and continue so to this day. In 2016 when I ran for Executive Director, I had the most fantastic surprise that Saturday. I looked up and there was my friend. I was so honored that after many years, she came to see me brought in. Several weeks ago, I asked her if she would attend this meeting. As I told her, you were there when I went in, and I would love for you to be there on my way out. And she is here. When I took on this job, I said to myself, "If I can do this job and be half as successful as Johnny did, then I did ok". Thank you, Johnny, for the inspiration, support and more importantly, being the ED that I hoped I would be because of your unknown guidance. Thank you and I love you.

There are way too many people to thank for everything over these years. You know who you are, with and without the stool and I hope you know how much I appreciate your support, friendship and understanding. You are one of the reasons that I am still standing here today.

To the Board members that I have served with over the years and to all you seated up here. I truly enjoyed my time with you all. I have been extremely fortunate over these years to work with some amazing individuals whose dedication and commitment was and still is unwavering. When likeminded people get together, that's a recipe for success and we have had fantastic years. Thank you.

I want to thank Larry Walton. Several years agio Larry began a FB page that is open and available to everyone...public and cooks. He brought together the three chili organizations in a way that no one else has. He monitors that page for unseemly comments and does not allow for any negative bashing of any of the three groups. That is not the intent of that page. It is social media being utilized correctly. I just wanted to say thank you Larry for your diligence and contribution to all the chili cooks.

I have to talk about my second spouse for a moment. I have said it before, and I will say it again. Not everyone is as lucky to get to work with and have a phenomenal connection over all these years. My time as ED was made better by the fact that we have that connection. He made me a better ED. The freakiest part was that we were so much alike in thought, action, idea and creativity. We fed off each other's passion and dedication. When we were working with sponsors, they could feel and see what this organization means to each of us on personal level. Yes, it is business...but they come away feeling more like a family member than a resource. It was a union that helped in part to push this organization into directions successfully that it had not ventured into before. Over the years, not only did we become workmates...we became better friends and that has changed into becoming family and for that, but I also couldn't have wished for anything else.

Dusty...I am so honored that I got to know you personally during these years. You are a great devil's advocate and I love you for that. I also love that you looked after me at TICC. It may be a small thing, but the 'have you eaten today". No...here's a sandwich. EAT IT! I watched you do the same thing to Kris...I was family!!! I enjoyed our discussions and the point of view. I enjoyed just getting to sit, relax and visit when things were really hectic, and I needed a break. Thank you all you have done and more importantly, thank you for your support and friendship. I am indebted to you for this and so much more. We are family.

You have been my everything when it came to me wanting to make this step. She is in the process of conducting her review, but unfortunately at the time of this printing, the review is not complete and the 2020 review report will be presented to the Great Peppers as a handout at the annual meeting in September.

The 2020 990 and 990T forms were mailed and accepted by the IRS on March 29, 2021. All 1099's were completed and mailed in a timely.

Mel Fitzhenry asked about the cost of the chairs for TICC. It was explained that those were paid for by the Friends of CASI. Mike Whitten replied that it was about \$70 a chair.

Mel Fitzhenry of North of the Brazos Pod, made a motion to accept the Treasurers Report, seconded by Jimmie Rodgers of Golden Triangle Pod, **Motion passed.**

SPONSORSHIP REPORT

Kris Hudspeth gave the following report:

With COVID impacting the world in 2020, the decision was made to not pursue any sponsorship agreements last year. All sponsors were notified that we would not have TICC in 2020, and as soon as we knew about 2021 would bring, we would be in contact.

With my pending departure from the CASI Board, Jennifer Sherfield has been in the training process to take over Sponsorship for 2022. As discussions with sponsors Have been taking place, Jen has been copied on all correspondence. At TICC, Jen will be formally introduced to each sponsor, and will accompany me during any sponsor engagements as I transition out.

At the time of this Summer Board meeting, we were hoping to have an update from Bolner's Fiesta by the meeting but was just notified that Mike Bolner has recently retired and there has been some shuffling of duties and they are playing catch up. At the end of 2019, beginning of 2020, there was interest from Bolner to sign a multi-year agreement, but that was not pursued due to the onset of the Pandemic. In our preliminary conversations recently, those discussion have been brought up, and I have mentioned that we are willing to commit to a multi-year agreement. At the beginning of August, we did reach an agreement with Bolner Fiesta on a three-year sponsorship contract. Bolner Fiesta has agreed to being a Gold Sponsor, as well as a Presenting sponsor of CASI through the 23-24 chili year, with first right of refusal for a new contract for the 24-25 chili year.

Kyle Adams and Richard Erwin will once again provide the funding for the chicken wings for the Wing Championship. Kyle approached me at the SWO in Wichita Falls about opening up the wing contest to anything goes, not just a fried buffalo wing. Kyle and Richard want to see wings expanded to help generate funds for the CASI Scholarship program. In talking with wing cooks, Keith, and Kyle, the idea to

split the wing championship into two categories (like we did with Salsa), was the best potential **avenue** to ensure the integrity of the Buffalo Wing contest, while providing the outlet for those that wanted to turn in other flavors/styles. In order to run a second wing contest, we would need approval from the Board, and from Southeastern Mills/Louisiana Hot SAUCE.

Which brings me to SE Mills/LHSJ...

I have spoken with Jonathan Eubans and Brad Olsen and confirmed that they will be back this year. I approached them with the idea about splitting wings into two categories and them sponsoring both under the same Sponsorship agreement and donations as in years past. They are a Gold level sponsor providing \$6500 worth of monetary donations. They have agreed to the splitting of wings and covering the prize money out of this Donations.

Renfro Foods will be back as a CASI Sponsor for the Salsa competition and providing chips and salsa for the bar area.

We have reached out to both Glazer's and L& F about beer and beer sponsorships. We have not received any donations from L&F in a number of years and do not anticipate that changing. Glazers has provided a monetary donation in addition to product; however, our representative has changed, and we have not been able to mesh schedules with our new rep.

Brewster County Tourism Council – Still unknown at this time

Constellation Brans/Woodbridge - Conversations continue

Statewide Remodeling – As many of you know, there was a possibility that Statewide would not be returning in 2020 due to a change in ownership at the end of 2019. Thankfully, the pandemic worked in our favor on this one, as it gave time for things to settle, and our Alcaldessa a change to extol the benefits of CASI and the what's/why/how we do things. With Dusty working on the new ownership from inside the company, and the lack of a Bean Sponsor, I was able to work a Sponsorship package with Statewide Remodeling to bring them back, this time as a GOLD SPOONSOR and the presenting sponsor of the Bean Championship. They will be providing a \$6,000 monetary donation, \$1500 of which will be allocated to the Bean prize money. I am still working with Statewide and the new owners on ad design and banner sizes. We are also working to get representation (other than Dusty) to TICC to present trophies AND SEE WHAT WE DO.

Lajitas will remain a supporting sponsor for CASI. Once again, they provided a discounted room block for CASI Sponsors, as well as providing comp rooms for our Band. Ron Barnes of Cowtown Pod made a motion to accept the report, seconded by Don Hoy of Colorado Chili Pod. **Motion passed.**

Bolner's Fiesta will be a presenting sponsor and ABC will be back. With Statewide being the bean underwriter we want Bolner's to stay as ABC because it is utilizing the HEB Brand of chili mix and is a good promotion for us at the Ranch. Having the royalty money has helped us stay solvent. Kris asked Mike where we were right now with royalties. We give everyone who signs up for ABC gets a free box.

Mike Whitten said we have received \$9980 to date. And that is just for the last two quarters. Richard Knight and Ted Fichtl were instrumental for working that deal to get it ready to turn over to the Board. Without those two gentlemen this project would not have gotten off the ground. This has turned into a windfall for CASI.

RANCH REPORT

The Ranch report was given by Steve Herries, Ranch Manager.

After a lonely 2020, the Ranch said she is looking forward to everyone returning!

The freeze of February 2021 caused some minor damage to the plumbing from the water catchment tanks at the Judging Pavilion. We were spared any costly damage from the freeze. We have an ice merchandiser at the main bar that is not working. The electrical seems to be fine. If anybody has any knowledge of refrigeration, I would welcome your input.

The roads were in good condition at my last visit, but that was before the rains started. I will be back at the Ranch between now and the Great Pepper's Meeting and will have an update at that time.

Bids are out for all the necessities for TICC: dumpsters, ice, and port-o-potties. Once our port-o-potty vender is confirmed, I will get contact info into the Trails for those who want their own for their camp as well as clean out charges.

There will be an online auction for electricity for TICC. Tentative dates are October 1-10 with the auction ending at 6:00 pm Central time. Starting bids will be \$150 for 30A service and \$200 for 50A service. Your spot will be marked, and you must be parked in your assigned spot to use the electricity.

By the start of TICC I expect the building at the entry gate to be insulated and have a new AC unit. A new power washer is in the works as the old one has outlived its useful lifespan. Additional railing is being added in the main bar area to prevent falling.

Let me know if you have any comments, questions or concerns.

Bob Steinle of Aces Pod made a motion to accept the Ranch report, seconded by Frances Manske of Chillini Pod, **Motion passed.**

Jim Ezell brought up entertaining selling gravel. Don Hoy said that the county has been using the gravel for maintaining the roads. Kris asked Jim to write something up and give to the Board post TICC. Mel said remember to consider the relationship with the county. They should always get first.

Krazy Flats

Keith Karaff gave the Krazy Flats report.

Before I do the Krazy Flats report, Miss Krenek are you ready? Pat and her peeps are going to be handing out the ballots. They will pick up right before we break for lunch. On the ballots for Directors, you are voting for two for the three- year terms and the Great Pepper of the Year.

When Don and Diana retired in 2019, Michael and I had agreed to take over the Flats in 2020 and that did not happen. Diana has agreed to help train us on the operation of the Flats and with Michael coming on the Board I get to be the new coordinator. Plans and training have been made regarding the transition the Flats to Michael and me. We have been working with Don and Diana on all aspects of the transition. At this point Diana and I have been working on the positive karma. I have been starting the purchasing of the merchandise for the store. We have had the foresight that nothing has a date on it just in case. There are some plans in the works for the Flats this year and I have an update on the ABC contest. With Bolners coming in and legitimizing this contest we started three years ago. That contest has outgrown the pavilion at the Flats. That event is not being moved to the main judging pavilion and Kris Steward will run the judging for us. I am extremely proud that the first year we did it we had 16 entries, in 2020 65 in two categories. Bolners is underwriting the money for each category equivalent to what we do on the Friday Events. All the entry fees from ABS goes to the scholarship fund so I am proud it is legitimized as a true CASI event now utilizing the HEB product, our chili mix. And it is moving across the ditch.

Golf cart parade will be held again on Tuesday evening. Going to try Mardi Gra one more time. This year we are going to reverse the route. It will start behind the Krazy Flats Saloon and wind it's way up Naked Hill and end at the main concession. There will be a huge Mardi Gras party going on so bring your beads and best Mardi Gras. The bars will be open. Janet Hughes who was such a success in 2019 with her karaoke. She is coming back, and she will be over there on Tuesday evening. It is going to be a party.

ABC is anything but chili. You must utilize the HEB chili mix and make anyth8ing you would like. You cannot turn in chili. You can make chili but use some other way in your recipe. They are sweet and savory.

We are going to continue with the Thursday morning breakfast and Thursday afternoon happy hour. We are also looking at running beer buckets specials throughout the week using different brands of beer. We will determine that by the previous sales during the week. We will run the bucket specials on beers we believe is not selling so well.

With the popularity of cornhole tournaments we are having a cornhole tournament on Thursday. Mike Whitten has agreed to work that tournament and are still working on the details. I can tell you that Amanda here at JG Wells Park is giving me two handcrafted belt buckles to go for the first-place winners.

Some of the entry fees from cornhole will also go to benefit the scholarship fund.

To honky tonk up the pavilion I am putting up a wall behind where the band plays as a backdrop. I am hoping it will become a great place for photo opps. Groups of people can get together, and it will say Krazy Flats, Terlingua, Texas. It will be made of old barn wood.

Also going to look at installing light bars and doing some redneck lighting for the stage. They are clip on shop lights with LED lights and it is cheap. It will add pop.

Also going to look at installing four metal platforms that will be welded up because we have a new sound system. Mixer, stands, mics and all donated by Becky and Brent Allen.

Michael and I are looking forward to working in the Flats. We have some very big shoes to fill and consider ourselves blessed that Don and Diana have considered being our mentors this year. Give a round of applause to them for all their years of service to the Flats.

Ron Barnes of Cowtown Pod made a motion to accept the report seconded by Don Hoy of Colorado Pod. **Motion passed.**

Alcaldessa Report

Due to the events that caused the cancellation of TICC 2020 this report will merely recap the GPM Old 320 Report.

The 2019 Winners of the stove drawing on Saturday were Linda McDonald and Bill Pierson.

At the Old 320 meeting Friday night prior to TICC two new members were introduced and welcomed: TJ Friedel and Lewis Garrett. The hot topic of discussion at the meeting was incorporating some of the unused show sites into the Old 320 to be used as POD sites or sites for large groups wanting to cook together. After much discussion the membership voted to not request the use of those show sites but to allow the Alcalde to do their job and help pods or groups find unused sites that are available to accommodate these groups.

Chili sales in 2019 resulted in \$600 in sales. We will discuss the use of the remaining funds at the Old 320 meeting at TICC in November. Renee Moore gave the following report.

The Governance Committee is not a very liked committee. You think Governance and you think government! And none of us like the government even though I get my paycheck from the government.

This year those on the committee were Steve Herries, Dick DeiTos, John Gray, April McDonald, Keven Stovall and Nancy Draper. We thankfully only had one complaint brought to us. For those of you who do not know, if someone has a complaint, whether it is a Great Pepper, a member, a Board member, that complaint is addressed to the ED. It is then moved to the Governance Committee for consideration and discussion. The Governance committee only discusses what the issue is, no other issues or personalities are brought into it. In many cases the committee does not even know who brought the complaint forward. As I said we only had one complaint filed. It had to do with a Great Pepper Meeting issue from last yea4. The Board in 2020. The Board passed the following motion. Due to the effects of COVID 19 that had a number of cookoffs within a state or province that has been completely out of control of anyone in 2020. The 2019 state totals would temporarily maintain into the 2021 year under the rule 7E1 for the 2021 chili year only. The complaint that was brought forward was it would have an adverse effect on the states of Arkansas, Illinois, New Mexico and Oklahoma. It was brought forward in complaint form from one of those states. The issue was discussed, and it was the committee's decision to recommend the Board consider the complaint. 



Trails

It has been 19 months since Mike Watkins agreed to lead a transition team as the Trails interim editor. As we have not yet identified anyone interested in assuming Trails editing responsibilities, Mike has removed "interim" from his title of Editor-in-Chief. He was supported by Carol Knight who has been a key member of the Trails team.

Since early 2020, the Trails team has used a (potentially) collaborative, cloud-based workflow that could (potentially) reduce the reliance on a single editor. We say "potentially" as we still are in search of additional team members including a new Editor-in-Chief. Prior computer experience and a willingness to learn is all that is required. Mike and Carol stand ready to welcome and train anyone interested in any aspect of the Trails production: Story collection and editing, photo collection and editing, copy editing, page layout, ad creation and editing, and proof reading. Unpaid internships on our staff are also encouraged for high school and college-aged students. A great way to add skills to their resume.

A few of the 2021 statistics and highlights are summarized below:

- The Trails has remained an electronic only publication throughout the 2020-2021 chili season
- Page count was 22-28 pages/issue and continues to increase as cook-off listings, ads, and results have expanded.
- Trails only 2020-2021 expenses are the Adobe Creative Cloud Subscription which allows shared access to Adobe InDesign page layout software. The subscription cost is \$197.42 per year.
- Paid ads generating \$599.50 revenue year to date: Southwest Open/North of Brazos Pod Cook-off, Houston Pod Cook-off, Bodacious Chili Powder, and Bill Renfro Memorial.

 A Trails email cleanup project has been in effect the last several months. I have hundreds of members that do not have emails attached to their account. I have cleaned up non-working emails. To this date I have around a dozen that I have not deleted, until I insure in fact these emails are no good. This could be a joint project led by Membership with support from the Trails, BOD, and other CASI members.

Again, we would like to reiterate that we welcome additional team members (temporary or permanent) and are actively recruiting for a new Trails editor. Mike and Carol will provide all the support and training necessary — all you need is a desire to give back to CASI and share our stories of chili, charity, and fun with the world! OLD BUSINESS

There was no old business.

NEW BUSINESS

Kris Hudspeth called on Brandy Rather.

Brandy stated that New Mexico Chili Society began their journey to become a 12-point state. After several years of hard work, we were able to have enough cookoffs in New Mexico state to be a 12-point state. Our other goal was to host a Men and Women's State Championship. For several years we have been able to offer these to our cooks because we had reached our goal in 2019 – 2020 chili year we were able to have these cookoffs in 2021. This year because of COVID and the lockdown of our state and because of the ruling to the Board to reduce the state points, we have been reduced to a NINE POINT state as result. And this governs our ability to have a New Mexico Men and Ladies State Championship in this year. Currently, the state of New Mexico we are at 10 cookoffs however three years ago New Mexico took over the jurisdiction of six Texas counties because Southeast New Mexico Social Pod was the closest pod. They were originally assigned to a pod out of Amarillo. These counties formed the NRA region. We have held three cookoffs in this area this year and they do not count for our state total because they are Texas counties. Today I am here to petition the Great Peppers and voting delegates to allow New Mexico to remain a 12- point state for the 2021 – 2022 so we can continue to offer these championships to the residents of New Mexico. I can assure you that as long as our state remains open,

we will get our 12 cookoffs in the coming year. Thank you for your understanding and support of the SENMCS.

Ron Barnes of Cowtown Pod made a motion that we accept the request, seconded by Craig Schlicke of Highland Lakes Pod. Renee Moore stated that Heart of Tennessee had also requested to be a 12-point state several years ago. They want to be a 12-point state **Motion passed.**

Mel Fitzhenry spoke of the collection taken up last year for the Toy Drive. He asked that we again donate to this fund. Pods started donating. Make your checks out to CASI. Keith thanked everyone for their donations and that at TICC we will have the toy drive also.

Mel recognized that today was September and requested everyone stand for the American Flag.

Keith said the rule changes we were going to be voting on start on page 49 in the manuals.

I Chili cooking Rules

A.2. NO FILLERS IN CHILI – Beans, macaroni, rice, hominy, or other similar ingredients are not permitted. a. Onions, peppers and tomatoes are permitted in chili as long as these ingredients are of a consistent size and are distributed evenly throughout the judging cup.

Earl Gorhum of Indiana Pepper Pod made a motion to change this rule, seconded by Gary Christiansen of Iowa Chili Pod. **Motion passed.**

Purposed change:

- II. Chili Judging Rules
- G. Announcing winners The top ten (10) or more chili winners and the top three (3) or more showmanship winners must be announced in reverse order of finish (e.g., 10th, 9th, 8th,,,,,3rd, 2nd, 1st). It is preferred that winners be announced within 30 minutes of the completion of final judging.
- 1. METHOD OF ANNOUNCING Winning chili numbers will not be revealed until announcement of winners. At that time, the ticket with the secret number that is affixed to the outside of each cu- will be removed and passed to the announcer (Persons announcing, monitoring, judging, or refereeing may cook if they so choose; however, if announcing, they need to APPOINT A NEUTRAL PARTY WHO DID NOT COOK TO HANDLE THE JUDGING CUPS, REMOVE THE TICKETS AND VERIFY THE MATCHING NUMBER.)

Ron Barnes of Cowtown Pod made a motion to accept, seconded by Patti Myers Jones of Rose City.

Motion passed.

Purposed change:

- V. THE CASI SANCTIONED COOKOFF
- B. 3. OTHER CASI RULES THAT AFFECT MULTIPLE COOKOFFS ON ONE SITE Only one cookoff will be held an any site on any one day. (Exception: Men's and Women's State Championships may be held on the same day at one site.)

4. CONSECUTIVE COOKOFFS ON ONE SITE. When cookoffs at the same site are scheduled for consecutive days, the same charity may benefit from each cookoff.

Ron Barnes of Cowtown made a motion to accept, seconded by Harvey West of Red River Valley Pod. **Motion passed.**

Purposed change:

VII. THE CASI TERLINGUA INTERNATIONAL CHILI CHAMPIONSHIP (TICC)

1. Qualified chili cooks

g. CASI POD COOKOFF – All established sanctioned Pods, in good standing for 2 years after seating are eligible for their annual recognized (one official Pod Cookoff per year) Pod cookoff winner to be automatically qualified for TICC.

Harvey West of Red River Valley Pod made a motion to accept, seconded by Bob Steinle of ACES Pod. **Motion passed.**

The following rules were put into place due to COVID and no longer apply. We will vote to remove the language.

- Rule E.1. Qualified Chili Cooks
- E1. Points earned by cooks and shows teams in 2020 will be brought forward to chili year 2021.
- E2. Cooks and show teams who qualified under the 2020 reduced points requirement will not have that qualification carry over to the 2021 chili year.

Ron Barnes of Cowtown made a motion to accept, seconded by Patti Myers Jones of Rose City, Motion passed.

This rule also needs the language removed:

- e. QUALIFICATION FOR CASI TICC
- 1. QUALIFIED CHILI COOKS
- g.1. All cooks and show teams qualified under b,c,d,f, g above in chili year 2020 will have those qualifications carry over to the 2021 chili year only.

Ron Barnes of Cowtown Pod made a motion to remove the language, seconded by Don Hoy of Colorado Chili Pod. **Motion passed.**

After July 1st I have been communicating with Brian Spencer and he is aware of what we are about to talk about and has given his blessing to discuss this. Great Peppers Meeting for 2022. The City of Gonzales love us. I would like to propose that because of the financial costs when we are here, we are able to do all this for the \$5000 that we had on hand. They have offered a

three-year deal. We already have a \$1300 deposit that would be refundable if we cancel withing the time frame.

Keith Karaff purposed that we hold the GPM here again for the next three year.

Ron Barnes of Cowtown Pod made a motion to accept his proposal, seconded by Earl Gorhum of Indiana Pepper Pod. **Motion passed.**

Keith said that traditionally at this time Gonzales has a BBQ cookoff. He has been approached about holding a Friday night cookoff with an 8 pm turn in time. We are in discussion with her right now. They want us back. I also had the discussion with Brian that if the Great Peppers agree with this that I would be the contact and use the contacts that I have already built.

Keith Karaff informed the audience that the Mass Gathering permits will be voted on in September.

Keith introduced the new posters for TICC. We only had the large posters made up because we were not sure if we were going to have TICC or not.

Kris Hudspeth said there were two pieces that have not been touched in years. The Red jacket. We are changing from the old style to a new updated style. This jacket is a higher quality.

Keith gave an update on Event Brite. There have been 117 or \$3355 for spectators tickets sold to date.

Keith Karaff said that the half peppers for final table will be back at TICC this year. These are made with resin.

Mel Fitzhenry, Black Sheep Pod, made a motion to withdraw the usage fee of \$25 for TICC. You have come up here and said that you are financially stable...you have money to buy this and that and you want \$25 a person from every CASI member to go out to Terlingua when they expect thousands of dollars to come in throughout the year, seconded by David Manske from Casinova Pod. **Motion failed.**

Keith Karaff played the video of the members we lost this year.
